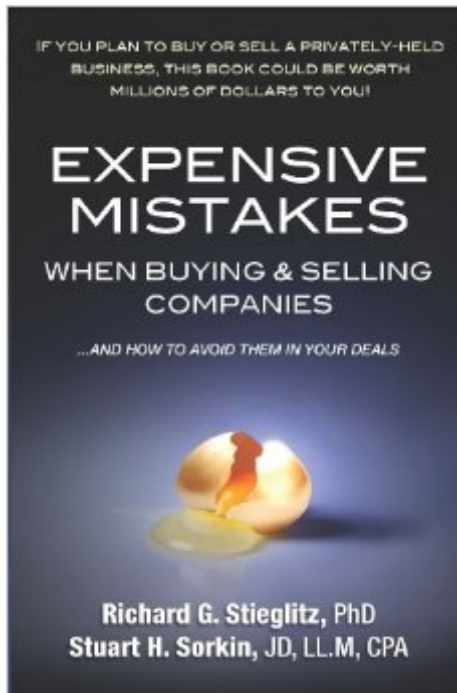

A simple check list at the back of the book highlights areas where value may reside so that you won't overlook anything. The book explains clearly the roles of everyone involved in a deal. It makes appropriate recommendations to use qualified and skilled M&A advisors. These are

balanced by horror stories of advisors run amok. The whole book is well balanced and perfectly structured. Best of all, the book is full of real life case studies; the stories of everyday men and women who made mistakes and paid the price (including Dick who provides a wonderful illustration throughout the book that ties all the concepts together).
