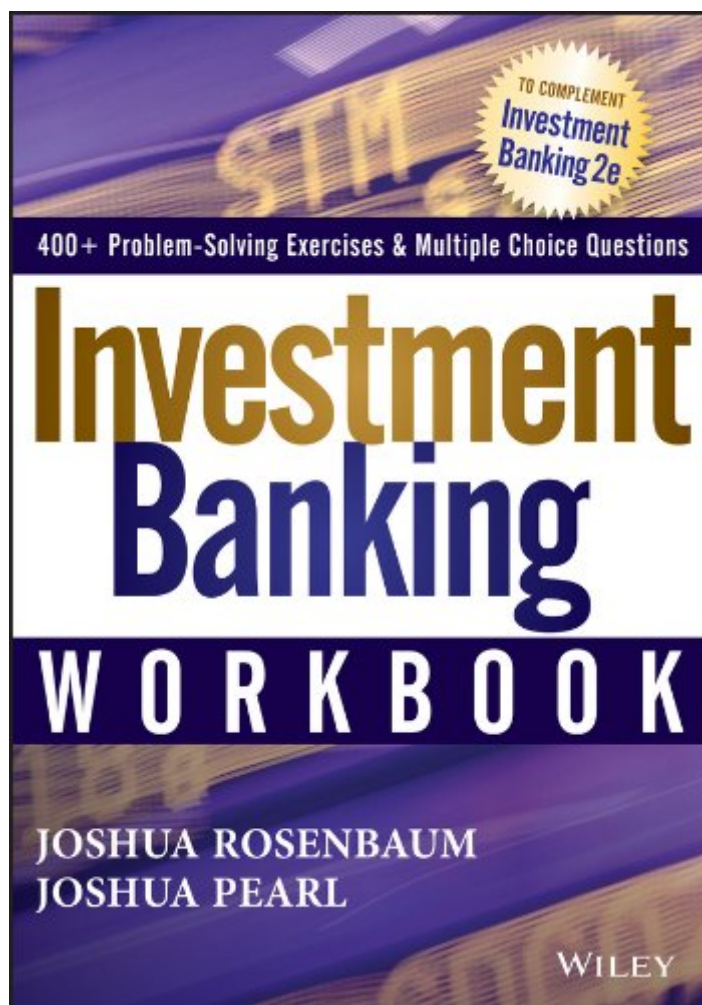

The thing I feel not too good about this order is the price. I wish that the price could be reduced a bit more for a Kindle version of this book. I would prefer a PDF version than Kindle version due to its restricted utility. However, it's a good book to have.

Without these additional exercises, you will not benefit 100% from the Joshuas IB book.

Hard to use unless you get the whole package that includes the CDs for models and the workbook. But overall, a great outline for all the valuation concepts. A bit repetitive for people coming from a strong accounting background.

This book is ok. There are so many math errors on it. Answers are always off. More in depth review. 3 simple errors. [...] c. states answer is 209.4 million from $4127.8 \text{ millions} \times 5.1\%$ I am assuming $5.1\% = .051$ (I hope) so $4127.8 \times .051 = 210.5178$. Not 209.4. f. $3931.3 \times 8\% = 314.504$ not 313.4. g. same things. There are plenty more errors, that makes everything really confusing, especially when you are using previous answers as variables for the next question, and the next question (like problem d. 560 ... 217.8 are wrong.) Soon, #'s are just so far off. Even when you use the books' answers for future questions its still wrong. Its ridiculous. Aside from that, I like the book, I am learning and the differences between my answers and the ones from the book, makes me think a little more. BUT It is very frustrating especially since I consider myself new to finance, and I want a definite answer to help me know I am doing things correctly not a stupid $\$@\$@\$@\$@\$@$ number.

This book has great example problems to reinforce your understanding. The answers are in depth, and help you understand where you may have made a mistake.
